**NOTICE PURSUANT TO ART. 84 OF ISSUER'S REGULATION**  
(Consob Resolution n. 11971/1999 and subsequent amendments )

Shareholders are hereby notified that has been filed with the competent offices of the Company Register, as provided for by art. 2501 *ter*, par. 3 of the Italian Civil Code, the Merger by incorporation Plan of Sistemi Dinamici S.p.A. into Leonardo – Società per azioni (hereinafter also the “Company” or “Leonardo”), approved by the Company’s Board of Directors on June 27, 2019.

With reference to Leonardo, the operation shall be submitted for the approval to its Board of Directors, pursuant to art. 2505, par. 2 of the Italian Civil Code, as well as art. 24.1 of the Articles of Association.

In this regard, Shareholders representing at least 5% of Leonardo share capital may exercise their rights under art. 2505, par. 3 of the Italian Civil Code, in the terms set forth therein and, therefore, not later than July 8, 2019, by registered mail with return receipt addressed to “Leonardo – Società per azioni, Piazza Monte Grappa n. 4 – 00195 Roma, to the attention of Legal, Corporate Affairs, Compliance, Criminal Law and Anticorruption”, or by email to the certified e-mail address [ufficiotitoli@pec.leonardocompany.com](mailto:ufficiotitoli@pec.leonardocompany.com), attaching in any case specific documentation certifying the share’s ownership.

Pursuant to Article 70 of Consob “Issuers’ Regulation”, the documentation relating to the mentioned operation (Merger Plan; Balance sheets as of December 31, 2018 of the involved companies; Report of the Board of Directors of Leonardo) is available to the public at the Company’s headquarters, at Borsa Italiana S.p.A., on the Company’s website ([www.leonardocompany.com](http://www.leonardocompany.com), under section Corporate Governance/Extraordinary Operations), as well as on the website of the authorized storage mechanism eMarket Storage ([www.emarketstorage.com](http://www.emarketstorage.com)).
